Administrative Reports

Mrs. Trowbridge reported in the elementary in 2018 student achievement proficiencies were in the 30 - 35 % range. The projections from early testing show student proficiency at 40 - 45%. Schools cube show that Thorp is doing higher than the country average. Teachers and students are struggling with no days off. The stress level is high. Top need for staff is for social and emotional help with students. Elementary will be bringing in a new curriculum that focuses on social and emotional needs for kids.

Student Services: Working on resurfacing the playground so kids with handicaps can get to the playground safely.

Mr. Foster reported that it was a great visit from guest Speaker Mike McGowen. He spent an entire day with Middle and High School students. He was able to break into smaller group sizes to address specific needs. He will be coming back to work with staff. Graduation date is set. Will be on the football field. As of now will allow 8 guests per graduate, they will need to socially distance in their own family group. Graduation will be livestreamed.
