Ordered more track uniforms they will be used for cross country also.

Adrian Foster: MS/HS Principal reported on academics at the MS/HS level. Teachers have done an incredible job adapting and changing how they have traditionally taught, classroom management, etc. They have done a great job teaching to the student's specific needs- breaking into smaller groups. PLCs are helping teachers make more database decisions and help breakdown target/need areas. Better classroom behaviors also in the lunchroom and hallways. Staff have improved to 100% of their objectives aligned with state standards per last schools cubed visit.

Mrs. Hanlin: Superintendent reported on running record monthly progress report in the past 30 days. Gave the board highlights from the schools cubed visit. Reported on the next steps report for MS/HS. They have had major gains- huge progress!
