The Annual Board Meeting of the Thorp Board of Education was called to order at 6:33 p.m. on Monday, August 16, 2021, by District Administrator, Angela Hanlin. Board Members present were Amy Penterman, Marie Karaba, Eric Werner, and Jeanette Kodl. Clint Klapatauskas was absent.

Also, in attendance were: Misti Trowbridge, Elementary Principal and Director of Student Services; Adrian Foster, 7 – 12 Principal; Peggy Hinkel District Bookkeeper and Cheryl Broda.

### Welcome and State of the District

Mrs. Hanlin welcomed all in attendance and gave an update on the many projects that have been completed at the school. She is working together with the athletic director to develop budgets for each sports program. She has set curriculum protocols for the year. She is working on budgets and monthly meetings and expectations for the upcoming school year. She was also happy to report a balanced budget for the first time in 3 years. With the help of Peggy Hinkel district bookkeeper many hours were spent getting the books in order. Going forward there will be a focus on budgets and adhering to them.

# Resolution A: Adoption of Tax Levy ss120.10(8-11)

Kodl hereby moves that the School District of Thorp, Wisconsin levy a 2021 tax against the taxable property of the School District of Thorp, as presented in the proposed budget for operating and maintaining the schools for the ensuing year.

Be it further resolved that the School District of Thorp, Wisconsin levy a 2021 tax against the taxable property of the School District of Thorp, as presented in the proposed budget for retirement of long-term debt previously authorized, and for the payment of interest on such debt.

The total amount levied shall be \$2,075,392 with a mill rate of 7.5 pending final approval by the Board of Education per Kodl with a second by Karaba. Voice vote. All ayes. Motion carried.

# Resolution B: Set School Board Salaries for the Year ss120.10(3)

Cheryl Broda moves to increase school board salaries by \$100, respectively. Annual school board member salaries shall be set at \$1900/year, with Clerk at \$2100/year, and the President at \$2000/year. A second by Adrian Foster. Voice vote. All ayes. Motion carried.

# Resolution C: Reimbursement of School Board Member for Actual Expenses ss120.08(1)

A motion was made by Cheryl Broda to reimburse school board member expenses at the same mileage rate as school district employees and reimburse all other related actual costs as necessary with a second by Adrian Foster. Voice vote. All aye. Motion carried.
