# Approve Achievement Gap Reduction (AGR) goals

The goals were reviewed and all is moving in the right direction.

#### **Administrative Reports**

Ms. Trowbridge reported that they are analyzing the minor and major behavior issues they are having with the Elementary students. Also, boys compared to girls and academics which might help understand why we are

seeing behavior issues. Ms. Trowbridge noted that the teachers are in the 2<sup>nd</sup> year of the new classroom management and so she is seeing more consistency and confidence in the classroom. She was excited to report that the results from the Special Education Self-Assessment Round 1 were almost perfect. And, the Fall Festival will not be held in the commons this year, rather a new event will be held...Trunk or Treat. Businesses were invited to bring vehicles in and hand out candy from the trunks of their vehicle for the students on October 31<sup>st</sup>. Mr. Foster reported on the PLC Group meetings and said they have been very productive. Teachers are connecting more than in the past. The Leadership team attended "Leading the Leader" training at CESA on October 15<sup>th</sup> which focused on unique classes that don't have a huge network to consult with. He also reported that we will begin to see movement to get the track and field, softball field update, and the transition of the tennis court to ball fields updated. Mr. Foster also shared that he is working with students to correct negative actions through Restorative Practices. In the past students served the time for their actions and moved on. Now they are required to confront the person that they did wrong to and take action to correct future behaviors along with some community service to promote positive behavior.

Mr. Humphries shared that he has been conducting board orientation with new board member, Amy Penterman per policy 162.0. He also shared that a team from Thorp will be speaking about the positive growth we are experiencing in Elementary student reading. A presentation will be held on October 29th and again on Friday during the Annual Convention in January. The administration team will be holding a Safety/Security Planning day on October 23th. This will include emergency instructions along with additional details for the 2019 Safety Plan. Mr. Humphries shared that the Blue Ribbon Task Force Recommendations will be coming and we are hoping to see some increased funding for the 4K students from 60% to 100%. He also shared a building and ground update. We still have some issues with the remodel that need to be addressed: HS Hallway Benches are peeling again (Market & Johnson will look at), Paint will be touched up, and Floor Tiles are coming up and as they are replaced we are not seeing the same thickness so we need to look back at our original warranty. Other items pertaining to the building are Classroom Cleaning and Energy Efficiency Benchmarking. Monthly energy consumption is down considerably from what was projected. On a final note for grounds, the bricks will be laid for the Healing Garden. Mr. Humphries shared the Final Budget Figures and Proposed Levy for the upcoming Annual Meeting.
