Mr. Blanford provided an update on Covid concerns or changes being made or that may be necessary affecting student education and sports.

- J. Kodl agreed that the overall wellness of the student needs to be considered and they need to get back to school. She also thanked the entire staff for their efforts in creating as much normality as possible for the students.

- A. Penterman thanked the staff for their efforts because she knows how hard it has been teaching her children at home.
- C. Klapatauskas said he felt that the MS/HS students should be back at school at least a few days a week.
