## **Administrative Reports**

Ms. Trowbridge was at a training session and so Mr Humphries reported on her behalf. The Trunk or Treat had 15 businesses and 2 student clubs participate. All went well but it was cold outside. Next Steps were reported from the Schools Cubed visit on 11-14-15. A life skills program will be added to elementary/middle school. This will require one additional paraprofessional. Information was also shared on the bids for the handicap accessible van.

Mr. Foster reported on the PLC Group meetings and said they now have added virtual PLC groups. Teachers are seeking professional development in the areas of curriculum standards and assessment. The curriculum steering committee will be meeting in December. Mr. Foster reported that the work has begun on the Athletic Facilities Fields. He also shared that the Restorative Practices are being used with student behavior issues. SAEBRS screening in the Middle School and High School has begun to identify students at-risk. This is the process of collecting data from teachers to make sure the social and emotional needs of the students are being met. Mr. Humphries shared that the WiRSA presentation given by Thorp Staff received positive feedback on the evaluations. WASB planning for the annual convention —Board Members are to let Mr. Humphries know if you plan to attend. Mr. Humphries provided a building & grounds update and stated that he is working on the perm-a-glaze benches that are peeling. He is still waiting on the flooring issues. On December 17<sup>th</sup> he will plan to attend the Legislative Literacy Planning meeting. Mrs. Humphries reported on various State Exams and reports and shared how the Thorp School District is doing. He also reported that he and Mr. Foster will attend a Hate/Bias Prevention Training in LaCrosse on December 3<sup>rd</sup>.
