Administrative Reports

Mr. Michaelis provided a Literacy and PBIS update. The Forward Exam will be coming in March. Planning for the 2019/2020 school year has begun. Parent/teacher conferences will be held next Thursday.

Mr. Foster reported that we will see a conference realignment for football and we will be playing against a few different schools. He has been working with the City on the Athletic Facilities Manager position. He also shared the Thorp Master Plan map that was approved last year. They really need to get moving on Phase 1 which will include adjustments to the softball field and the addition of some additional fields where the tennis court is located.

Ms. Trowbridge reported that a self-assessment parent survey will be available with chrome books on parents' night. She shared that the CESA contract is being reviewed and hopefully we can see some adjustments to our cost for their services. She is also reworking the model for the Comprehensive School Counselor.

Mr. Humphries shared that the Governor will be giving his address next week. It is anticipated that he will be asking for a lot of dollars for education and for a separate line for vouchers on the property tax bill. Mr. Humphries will forward information on Blue Ribbon Funding.
